Memorandum of Understanding

between

Musikhochschule Lübeck – Lübeck University of Music

and

The Odessa National A. V. Nezhdanova Academy of Music

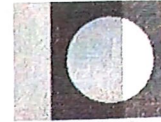
The Odessa National A. V. Nezhdanova Academy of Music and Musikhochschule Lübeck (MHL), agree upon continuing cooperation in various spheres of music, science and research. The cooperation shall intensify the mutual relations, the comprehension of culture and the exchange of experiences in teaching and research in connection with artistic and scientific subjects.

For this purpose, the following arrangements are agreed:

1. Both institutions organize an exchange for particularly qualified students. Each semester during the term of this Memorandum of Understanding (MoU), each institution may send students to be enrolled at the other institution.
2. Applications should contain a recording or other relevant material which proofs the artistic or scientific skills of the applicant. Each institution reserves the right to decline applications for insufficient performance.
3. Applications can only be submitted via the European Online Application System – EASY DREAM APPLY. Applications outside this portal will not be processed.
4. All exchange students must be officially registered at the home institution and if required pay the necessary fees there. Each host institution will provide tuition fee waivers for the exchange students.
5. Exchange students may apply to any academic program offered at the host institution, but the host institution reserves the right to exclude students from restricted enrolment programs.
6. Students and academic staff/teachers are personally and solely responsible for their valid health and liability insurance in the host country.
7. The host institution offers help or advice to find a domicile.
8. The cooperating institutions will provide each other with adequate information on the performance of participating students, including an official transcript of credits, or its equivalent, as soon as practicable after the students' completion of the exchange.

9. The associates will make efforts for the exchange of academic teachers. An exchange between both teaching staff members shall promote the mutual interests in research and teaching and stimulate the institutions in this area. Because the teacher exchange cannot be rendered feasible for the whole study term, it should be organized as a master class or seminar.

10. Concerning the planning and realization of projects, both institutions will follow the regulations of the host institution and host country. All projects' and common events' financial modi operandi that arise within this agreement will be negotiated apart and stated in a separate agreement.

11. Additionally, exchange of information will be promoted within the scope of partnership, i.e. about the structure of both institutions, their courses or their study offers. Mutual help should be given for organizing books and scores being difficult of access.

12. The Memorandum of Understanding shall remain in force for a period of three years. Any modification or cancellation must be notified in a written agreement to the associated institution six months in advance.

13. The present Memorandum of Understanding is no way intended to create legal or binding obligations on either party. It serves only as a record of the parties' current intentions to enhance the student exchange program and the relationship of the Institutions going forward.

14. Legal deputies arising under this Memorandum of Understanding are subject to handling by the appropriate court in Lübeck (Germany). German law applies.

15. Due to the current corona crisis, collaboration may also happen via video conferences and teachings, as long as the crisis is going on and travelling is impossible.
