

**Admittance Rules**  
**to the Odessa National Academy of Music named after**  
**A.V.Nezhdanova**  
**for foreign citizens in 2019**

Foreign citizens who stay in Ukraine legally and have a corresponding educational degree (educational qualification level), who speak the language of instruction and expressed a desire to get a higher education are admitted to Odessa National Academy of Music Ukraine named after A.V. Nezhdanova. The training is carried out only in full-time department.

The admittance of foreign citizens for training:

The education of foreign citizens at the ONMA named after A.V.Nezhdanova is carried out according to the accredited educational programs.

Odessa National Academy of Music named after A.V.Nezhdanova carries on the admittance of foreign applicants for the speciality "Musical Art", specializations:

- 1. Piano, organ;
- 2. Orchestra string instruments;
- 3. Orchestra wind and percussion instruments;
- 4. Folk instruments;
- 5. Singing;
- 6. Choir conducting;
- 7. Opera-symphonic conducting;
- 8. Music studies;

For entering the Odessa National Academy of Music named after A.V. Nezhdanova foreign citizens provides personally:

The fact of acceptance of application is registered by the The Admittance Committee in the Unified Database.

Along with the application the applicant provides:

- 1) The document (the original and its copy) of the previously received education, on the basis of which the admission is carried out (translated and legalized at the Consulate of Ukraine).
- 2) The attachment (the original and its copy) of the previously received education, on the basis of which the applicant enters (translated and legalized at the Consulate of Ukraine).
- 3) The document (original and its copy), which contains information about the content of the curriculum in the previous degree of higher education, the number of credits, the duration and academic performance in training disciplines (for applicants to the magistracy) (translated and legalized at the consulate of Ukraine).
- 4) The copy of the applicant's passport notarized and translated into Ukrainian.
- 5) Medical insurance policy in Ukraine.
- 6) 6 photos.

7) Medical certificate (original and its copy), indicating the absence of contraindications for training in Ukraine (legalized at the consulate of Ukraine).

8) Medical certificate indicating the absence of the disease for AIDS.

The acceptance of applications and documents, creative competitions, competitive selection and enrollment for training of foreign applicants to obtain the level of "BACHELOR" is held:

- from June 25 to July 2, 2019,

Dates of creative competitions:

- from July 3 to July 10, 2019

Terms of enrollment:

- August 01, 2019

The acceptance of applications and documents, creative competitions, competitive selection, the enrollment for training of foreign applicants to obtain the level of "MASTER" is held on such dates:

The reception of documents from 15 to 25 June 2019.

The dates of creative competitions from June 25 to July 1, 2019.

The publication of the rating list on August 01, 2019.

The enrollment is carried out no later than August 01, 2019.

Foreign citizens entering the bachelor's level, regardless of their specialization, have to take creative contests:

1. Creative competition in the speciality.
2. Creative competition in foreign language.

Foreign citizens entering the “master” level, regardless of their specialization, have to take creative contests:

1. Creative competition in the speciality.
2. Creative competition in foreign language.

The results of creative competitions are evaluated on a scale from 100 to 200 points. The applicants who have received a rating below the established level (140 points) are not allowed to participate in the further competitive selection.
